

EXCLUSIVE insurance covers all healthcare provided to the client in any medical facility. Its benefit, therefore, lies in the fact that it provides the client with the certainty that the insurance company will not under any circumstances deny insurance benefits and the costs of treatment will not be charged to the client.



- Reimbursement for the provided medical services that mirror public health insurance cover.
- ✓ Indemnification also covers diseases incurred prior to commencing insurance cover (e.g. chronic diseases).
- Beyond public health insurance, EXCLUSIVE health insurance includes an assistance service, repatriation, transport of the deceased and payment of regulatory fees.
- ✓ The client can arrange insurance to cover the costs of post-natal care for newborns.
- Clients are allocated a special contact telephone number that is specified on the insurance card.



DIAMOND comprehensive health insurance for foreigners



- Tailor-made insurance policy allowing to take the client's specific needs into account, especially in situations where the client is suffering from chronic or other serious disease.
- ✓ Indemnification also covers diseases incurred prior to commencing insurance cover (e.g. chronic diseases).
- Beyond the public health insurance, DIAMOND health insurance cover includes an assistance service, repatriation, and transport of the deceased who was insured.
- Clients can obtain health services (hereinafter HS) in both contractual and non-contractual healthcare facilities Guarantees cannot be provided in noncontractual medical facilities without direct payment for the provided health services.
- ✓ Optional additional insurance cover: dental hygiene, optional vaccination, post-natal healthcare for newborns, above-standard services.

Basic health insurance for foreigners (for stays up to 90 days)



- ✓ Unique health insurance for foreigners, which is similar to the public health insurance cover.
- Reimbursement for preventive and dispensary healthcare including care related to pregnancy and childbirth, for emergency dental treatment, for drugs and medical items prescribed by a physician as part of outpatient care.
- ✓ It is not necessary to undergo an entrance medical examination, except for the optional "Newborn" additional insurance cover.
- ✓ The "Newborn" additional insurance cover includes the reimbursement of costs for postnatal care of the newborn of the insured mother.
- ✓ 24/7 assistance services from the reputable AXA ASSISTANCE.
- ✓ This policy may be arranged for a period of 4 to 60 months.
- ✓ The indemnification limit ranges from CZK 1,800,000 to CZK 3,000,000 per each insured event.

- ✓ Reimbursement of costs for necessary and urgent treatment and hospitalization in all health facilities in the Czech Republic to the necessary extent.
- ✓ 24/7 assistance services from the reputable AXA ASSISTANCE.
- ✓ This policy may be arranged for a period from one day up to 36 months.
- ✓ This insurance cover is intended for all age groups.
- ✓ The indemnification limit ranges from CZK 1,800,000 to CZK 3,000,000 per each insured event.
